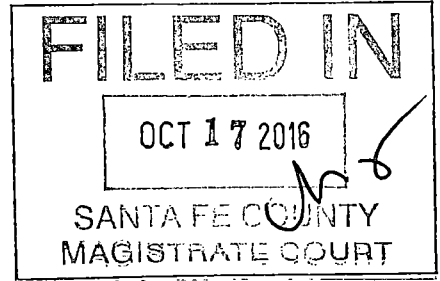

CRIMINAL COMPLAINT

CRIME: Murder in the first degree (open charge)
Tampering with Evidence (highest crime committed is a capital, 1st or 2nd degree felony)

The undersigned, under penalty of perjury, complains and says that on or about September 4, 2016, in the County of Santa Fe, State of New Mexico, the above-named defendant did: (here state the essential facts)

Count 1: Murder in the 1st degree (open charge)0001
did kill *Elvira Segura*, a human being, without lawful justification or excuse, by any of the means with which death may be caused, contrary to NMSA 1978, § 30-02-1 & 30-02-3. (a 1st degree, capital felony)
